End of Meeting Record

Prepared by Fritz Horton November 24, 2021 Our Club bylaws ask that the Treasurer produce a budget forecast for the coming year. Please accept the following as my report:

Our new fiscal year will be quite unlike past years in activity, income, and expense as a consequence of hosting the 2022 ACBS National Boat Show.

BACKGROUND:

Our club has two (2) bank accounts.

- (1) Show account set up to record all show activity.
- (2) Club Account Normal yearly club activity.

SHOW ACCOUNT:

A very detailed budget has been prepared for all pre-show Club Sponsored Event expenses. Sponsorship targets were calculated to cover these expenses, sponsorship dollar commitments have been met, and exceeded, and dollars have been flowing into the separate LCACBS account which was created to collect and monitor all income and expense by our club associated with the show.

The Show Account balance at the start of FY 22 is \$23,500 with an additional \$9,000 deposited directly to ACBS.

Upon completion of the National Show, ACBS and LCACBS representatives will meet to agree allocation of income and expenses between groups.

LCACBS CLUB ACCOUNT:

We are presently organizing waterfront activities, show support, calendar programs, etc. and do not yet have estimates of these costs. We will not have our regular LCACBS Boat Show this year.

Our Club account at start of FY 2022 is \$15,902. For comparison, our End of Year balances were:

IN SUMMARY:

Our Club account is in very good condition, the highest in the last five (5) years.

Our Show account is very well budgeted. Sponsorship targets are met, and money is flowing in. I believe LCACBS is well positioned with adequate reserves to support the 2022 National Show, of course assuming good expense control. For tight control, we have limited the number of debit cards issued to assure charges are made to the correct accounts.
