- 1) Minutes of previous meeting were approved unanimously.
- 2) LCMM & LCACBS -- Presentation (Susan McClure & Lauren Ross, Susan H.):
 - a) Susan McClure will move to the Vermont Art Council as its Executive Director, leaving April 21, with Lauren Ross and Chris Davis as co-directors.
- 3) Membership:
 - a) Membership at 100
- 4) Treasurer's Report:
 - a) Current Balance: \$22,206.83
 - b) Income: \$1,125 (dues) plus \$500 (dinner reservations)
 - c) Expenses:
 - i) \$500 (Splash) plus \$1,000 (Basin Harbor).
 - ii) Donations: \$400 (Essex Historical Society) plus \$250 (Hudson Powerboat) plus \$500 (Hudson River Lighthouse) plus \$500 (LCMM)
 - d) Remainder in a CD at 5.5%
- 5) Newsletter (Greg Woodard):
 - a) All welcomed Greg as our new editor for the chapter newsletter.
- 6) Chapter Budget (Sue H.):
 - a) January budget shows a deficit of approximately \$1,445.
 - i) Deficit may be reduced because the Fall Meeting was set at \$2,650, and Holly managed to reduce the room rental by \$670 and we used last year's numbers that included 13 dinners we did not serve.
 - b) Boat Show:
 - i) Dockage fees for exhibitors (\$2.25/ft.) will be added to the entry fees.
 - (1) Current practice for transients is \$5/hour with 1st hour free.

- (2) Despite Erin's claims that we have always paid dockage fees for the show, Steve and Mike O'Brien know that is not true.
- ii) Splash will charge \$1,650 to rent the Boathouse space plus the cost of the caterer at \$3,250 for minimum 50 attendees.
- iii) Total dockage for a 20' boat, our registration at \$40 and dinner for 2 would be \$184.
- iv) In '19 we paid a lot less...
- v) Dinner at Main Street Landing: \$150 for rent, catering & bar service it \$1,000, plus tables & chairs, tablecloths, dishes, cutlery.
- vi) July 15 is one of the "no activities" dates specified by Act 250 for the park.
- vii) Big chapter expense is for the dinner (\$2,400 for 50, \$2,800 for 30) and leave at least \$15,000 in the bank.
- viii) Steve will try to obtain space for the land exhibits and discuss with the mayor his Wednesday morning bagel meets at Ethan Allen Shopping Center.
- ix) ue will set up a committee to explore other venues for the Boat Show.
- c) We need more advertising revenue.
 - i) Greg has developed a one-sheet flyer for volunteers to give to potential sponsors.
 - (1) Flyer provides information to show the levels vs. value of sponsorships and help volunteers make their requests.
 - (2) He requested current contact information for almost all the organizations.
 - (3) \(\subseteq \) He will be contacting folks in west-central VT and at Lake George.
- d) Fall Dinner:
 - i) Holly reserved the room at Basin Harbor. Final arrangements for dinner menu TBD.

7) Fiscal Year Change:

a) Al Dunham moved to approve changing our Fiscal Year to match Calendar Year. Rich Butler seconded; all approved.

8) Strategic Plan:

- a) Sue's survey results showed most support increasing our membership, followed by more interaction with other chapters.
 - i) We should ask our members for their affiliations with other chapters to facilitate communications with those chapters.
 - ii) Holly suggested we contact southern chapters for interest from those who travel north in summer.
 - iii)

 Sue will investigate rendezvous & cruises elsewhere.
- b) Third preference is for more public exposure.
 - i) Best opportunities are in Burlington or Plattsburgh.
 - ii) Greg suggested we are missing opportunities to allow the public to easily donate to us.
 - (1) Steve suggested we add a QR Code to the program to facilitate more interaction via our website donations.
 - iii) Fourth preference is for more interaction with related organizations (like LCMM).

- iv) Fifth was to become a charitable organization.
 - (1) Works to make sponsorship more attractive and to minimize our tax liabilities.
 - (2) Others with that status: Adirondack chapter and Lyman owners' group.

 - (4) Sue will send Rich "how-to" info from the Adirondack chapter.
- v) Sixth preference is to increase our status with the City of Burlington...
